## Minutes of the Continuous Board Meeting 2019-2020

- **Appointment:**  
Benjamin Rossman signs the CCF conflict of interest statement on August 6, 2019, and is confirmed as the chair of the Local Arrangements Committee for CCC 2021.

On Sep. 5, 2019, the books for CCC'19 are closed with a surplus of \$74.70, resulting from a registration income of \$13,995 and conference expenses of \$13,920.30.

  - On Feb. 5, 2020, the Board approved Valentine Kabanets as the Program Committee Chair for CCC'21.
  - Valentine Kabanets signed the COI statement and the appointment took effect on Feb. 11, 2020.
  
- Motion:
 

Due to the Covid-19 situation, CCC 2020 will not take place as a physical conference at Saarbrücken between July 28-31 as originally planned. Instead the conference will be held in a virtual online format during a subset of those days. The exact specifics of the conference format, and adjustments to the budget and registration fees, will be decided after further discussions (and possibly a vote) within the board, with input from the local arrangements committee chaired by Markus Blaser. The local arrangements team will continue to help with the planning and execution of the conference in the online format.

CCC 2020 will have the following general format, with exact details to be worked out by the PC and LAC chairs:

Offline part: 30 minute talks to be uploaded by July 1 via an author registration site, with an optional second in-depth part which can be uploaded as a separate 30 minute talk. The talks will be hosted on a CCC YouTube channel.

Online part: A live component of 5-10 minute talks on the papers and perhaps a live chat forum where authors will be available for some period. There will also be two invited talks, a business meeting (shorter than usual), and a board meeting. These will be spread over 3 days July 28-30.
